GENERAL INFORMATION

Pure & Simple 90% improves the effectiveness of certain post emergent herbicides, desiccants, defoliants, insecticides, fungicides, acaricides, and miticides to enhance activity.

Pure & Simple 90% improves performance of the active spray ingredients by providing more uniform distribution and better wetting of the plant surface.

USE RATES

For ground, air, and aquatic* use applications.

Post Emergence Herbicides : 1 to 4 pints per 100 gallons (0.125% to 0.500% v/v) spray solution.

Fungicides, Insecticides, Acaricides: 4 to 8 fluid ounces per 100 gallons.

Mixing: Unless instructed otherwise by accompanying pesticide label, add Pure & Simple 90% as the first component to the spray tank.

Note: The accompanying pesticide label often provides specific use rates, mixing, and application instructions, and any additional precautionary statement. Always read and follow label directions of the pesticide being applied.
