General Information

Spectra Max Tech is a Manufacturing Concentrate to be used in the production of Spectra AMS or an equivalent dealer-labeled product.

Spectra Max Tech contains an integrated water conditioning system with an optimized rate of viscosity modifiers.

When blended with the appropriate level of ammonium sulfate solution, the final product is a user-friendly, complete water conditioning system.

Directions For Use

Spectra Max Tech is a manufacturing concentrate to be commercially blended with ammonium sulfate solutions.

Spectra Max Tech is not to be used as a tank mix adjuvant, and is not for retail sale.

Spectra Max Tech must be used in accordance with the supplemental manufacturing procedure guidelines. Read and follow these guidelines carefully.

Hazard Statements

Causes skin irritation. Causes serious eye irritation.

Precautionary Statements

Wash thoroughly after handling. Wear protective glove/eye/face protection. IF IN EYES: Rinse continuously with water for several minutes. Remove contact lenses if present and easy to do; continue rinsing. Immediately call a poison center or doctor/physician. IF ON SKIN: Wash with plenty of soap and water. Take off contaminated clothing and wash before reuse.

Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a closed container. Store above 32° F. Store away from heat or open flame and oxidizing materials. **Keep from freezing.**

Disposal: Wastes resulting from this product may be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent) during mixing and loading. Returnable mini-bulk tanks should be rinsed and dried thoroughly. If the tank has reached the end of its usable life, dispose according to local, state and federal regulations. First Aid
