General Information

K-SURF improves the effectiveness of certain post emergent herbicides, desiccants, defoliants, insecticides, fungicides, acaricides, and miticides to enhance activity.

K-SURF contains nonionic surfactant and humectant properties.

K-SURF improves performance of the active spray ingredients by providing more uniform distribution and better wetting of the plant surface.

Directions For Use

The accompanying pesticide label often provides specific use rates, mixing, and application instructions, and any additional precautionary statement. Always read and follow label directions of the pesticide being applied. For ground and air applications.

Post emergence herbicides: 1 to 4 pints per 100 gallons (0.125% to 0.500% v/v) spray solution.

Fungicides, insecticides, acaricides: 4 to 8 fluid ounces per 100 gallons.

Unless instructed otherwise by accompanying pesticide label, add K-SURF as the first component to the spray tank.
