Colorizer is a seed treatment colorant for use with any aqueous based seed treatment product designed for slurry application. The use of a jar test to confirm compatibility is recommended prior to large volume mixing.

Colorizer is available in red, orange, blue and green. Other colors available upon request.

Suggested Use Rates

Add Colorizer to slurried treatments at a rate of 0.25 to 1.5 fluid ounces per 100 pounds of seed. Select rate based upon preference for seed color intensity.
