SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing Media:	Alcohol resistant foam, CO ₂ , powder, or water spray. Do not use water jet.
5.2. Special Hazards:	Combustion may yield smoke, carbon monoxide, and other products of incomplete combustion. Oxides of sulfur, nitrogen or phosphorus may also be formed. Never use welding or cutting torches on or near container, even if empty.
