First Aid

Pure & Simple NIS contains nonionic surfactant and humectant properties.

Pure & Simple NIS improves performance of the active spray ingredients by providing more uniform distribution and better wetting of the plant surface.

Directions For Use

Pure & Simple NIS can be use for ground and air applications.

Post emergence herbicides: 1 to 4 pints per 100 gallons (0.125% to 0.500% v/v) spray solution.

Fungicides, insecticides, acaricides: 4 to 8 fluid ounces per 100 gallons.

Unless instructed otherwise by accompanying pesticide label, add Pure & Simple NIS as the first component to the spray tank.
