#### General Information

Hydro-Wet TG helps manage and conserve water by reducing the surface tension of water beginning with first watering or rainfall. Water having a lower surface tension is a "wetter water."

Hydro-Wet TG reduces rain and irrigation run-off loss.

Hydro-Wet TG fights drought by getting water down to the deep (4" to 6") root zone. Continued use can minimize localized dry spot damage on turfgrass.

Hydro-Wet TG aids water infiltration and drainage of compacted or hard-to-wet soils.

Hydro-Wet TG helps water penetrate heavy thatch for more uniform wetting and increased efficiency of fertilizers and pesticides.

Adequate soil moisture in the root zone ensures availability of both water and plant nutrients to the plant. A soil moisture reserve is important in maintaining a plants appearance and vigor throughout the growing season.

Used regularly, Hydro-Wet TG can reduce both irrigation time and frequency.

#### Use Directions

**Lawn Care:** Apply Hydro-Wet TG at a rate of 1 1/4 to 2 1/2 lbs per 1,000 sq. ft. Where localized dry spots appear, additional applications of 1 1/4 lbs per 1,000 sq. ft. are suggested every 2 to 4 weeks throughout the summer. Water treated areas for at least 15 minutes immediately after application to remove granules from turfgrass. Make application during morning and evening hours. Avoid application during mid-day periods of high temperatures (i.e.; 90°F).

**Established Gardens and Landscaping:** Apply Hydro-Wet TG at a rate of 2 1/2 lbs per 1,000 sq. ft. in early spring. Repeat application in 3 to 4 months to all trees, shrubbery and mulched areas. Irrigate following application.

**Newly Planted Nursery Material and Soil Media:** Apply 1 1/4 to 2 1/2 lbs per 1,000 sq. ft., working granules into the top soil. Repeat applications every 3 to 4 months. Irrigate following application.
